

The integration of environment into humanitarian action is critical to ensure effectiveness, sustainability and accountability of humanitarian operations.

considerations Integrating environmental during the early phases of emergency response strengthens people's livelihoods, fosters resilience and reduces the risk of cascading impacts and future emergencies.

Proactively addressing environmental issues in humanitarian action can contribute to reversing unsustainable trends leading to deforestation, desertification, soil erosion and pollution; all of which have significant impact on community resilience, biodiversity, food security and economic development.

The United Nations Environment Programme (UN Environment) and the UN Office for Coordination of Humanitarian Affairs (OCHA) Joint Unit (JEU) works at the interface of environment and emergencies, liaising closely with humanitarian and environmental actors to strengthen the sustainability of humanitarian response.
